## **Check In Document**

### Peninsula Vallarta Tower I

- Condominio Específico Residencial Península Torre I (Tower I) is a Residential Condominium and not a Temporary Accommodation Resort. By entering the property, every person accepts the responsibility to behave as a guest of a private house, in accordance to the Condominium Bylaws and regulations.
- Tower I is completely independent in security, policies and administration from Tower II
  and Tower III, the other two towers in Península Vallarta, nevertheless some of these
  policies and regulations might coincide and be shared.
- 3. The Civil Code of the State of Jalisco entitles the Administration of the building to forbid entrance, ban or remove from the Condominium any person showing any aggressive, irresponsible or uncivilized behavior. In this way the security and comfort of every user of the building will be protected.
- 4. Promises made or rules not explained, while renting a private unit at Tower I have no influence over the application and enforcement of the rules in this Condominium. It's the responsibility and obligation of every renter to read and sign these rules before entering the Condominium. These rules supersede any representation made by the renter of any unit.
- 5. Only Homeowners and long-term renters (3 months or more) can have visitors or guests in units, nevertheless, in this last case, the number of registered renters plus the number of visitors/guests could never exceed the maximum occupancy indicated in point 7.
- 6. All renters must wear ID bracelet at all times. Anyone, with the exception of Homeowners, not wearing a bracelet will be removed from the Condominium. Every guest should handle the bracelet back to the Front Desk before checking out, otherwise the homeowner of the unit is subject to a penalty.
- Maximum occupancy per unit type: Unit type A: 10 persons // Unit types B and C: 8 persons // Units type D and E: 6 persons. All person, regardless of age is counted (including babies).
- 8. Renters won't be granted access to the Condominium if the Owner or Manager of the unit to be used is not present in the Complex to receive them, or has provided writing notice in advance to the Condominium's Administration, notifying of the full names of those authorized, using this forma. Additionally, before being checked into the Condominium, every person must prove identity with an official photo ID.
- Electricity is only reloaded from Monday to Saturday, from 9 a.m. to 5:00 p.m., and only to those units current in their fees.

- 10. Immediate Legal Action will be taken against anybody who attempts to use a fake bracelet or a false ID, and persons using a unit connected with the use of a false bracelet or ID will be removed from the premises.
- 11. This Condominium has 24/7 surveillance. Videos, sounds and images are automatically kept in an onsite server.
- 12. The only criteria to be used in Tower I is the one expressed every year by the Homeowner's Assembly. Decisions and actions of the Administration and of the Security Department will only be based on the Bylaws of the Condominium Regime. Exceptions cannot and will not be made.
- **13.** Guest and Visitors will be have to leave the premises once they have handed the key of the Private Unit to the person that rented the apartment.
- **14.** Cleaning, management, security and maintenance to the private units are not provided by Tower I's Administration.
- **15.** The use of the gym and the interior jacuzzi is exclusive to Tower I's homeowners and residents (long-term).



# PENINSULA RESIDENTIAL REGULATIONS

# SHORT TERM.

# Welcome to the **Peninsula Condominiums Puerto Vallarta.**PLEASE BE AWARE THAT THE PENINSULA IS AN EXCLUSIVE PRIVATE RESIDENTIAL COMMUNITY AND NOT A HOTEL.

-By signing this document the renter or guest obliges to respect ALL the rules. Disobeying the rules may result in you being required to leave the property. Renters and guests must register in Security (at the Reception) upon arrival. -In order to be allowed into any condo you must read and sign this document.

# -RENTERS DO NOT HAVE THE RIGHT TO RECEIVE EXTERNAL VISITS OR GUESTS.

- -The only people allowed into the property are those whose names appear on the renter registration form which must be filled out by the owner of the property prior to the renters arrival. ONLY THE OWNER may make changes as to the number and names of guests listed.
- -Occupancy will not exceed the maximum number of guests allowed including children in the Condominium Regulations. 8 people for B C Units : 10 people for A D Units
- -The people listed on the renter registration must sleep at the designated condo. Listing names of people with the intention of visiting for the day is not allowed.
- -Each adult listed on the renter registration must provide a form of government issued ID.
- -It is mandatory that the Peninsula bracelet is worn at all times. If your bracelet breaks or comes off you must immediately surrender it to security and a new one will be issued. Any attempt to make a fraudulent or fake bracelet will result in removal from the Peninsula property.
- -Shoes and shirts are required in all common areas of the building.
- -Wet clothing of any type is not allowed in the lobby, elevators and other indoor areas. You must be completely dry after using the pool or ocean before entering the building.
- -It is forbidden to hang towels or other objects on balconies rails.
- -Pets are not allowed.
- -Loud noise, musical instruments, or music is not allowed anywhere in or around the pool area or beach at any time. Speakers of any type are not allowed. The only type of audio device that is allowed is personal headphones that cannot be heard by others. Playing any type of audio directly from a device on an internal speaker such as a phone, tablet, computer, or I Pad is prohibited.
- -Glass is not allowed in the pool and beach area, even in coolers.

- -Children under 15 must be supervised at all times.
- -The gym is for adults 15 years old and older.
- -Renters are not allowed to use the Game Room unless it is for an event open to everyone in the building.
- -Babies must wear swim diapers when in the pool. Regular diapers or having the baby be naked is not allowed.
- -The furniture in the common areas is for sitting only. Children cannot jump or play on them.
- -No minors are allowed in the Computer Center, this is a work area.
- -Smoking is not allowed in the indoor common areas. In the pool area you are only allowed to smoke in the designated areas immediately next to the cigarette receptacles. Any damage caused by cigarettes to any Peninsula property will need to be paid immediately to the Administration.
- -The use of chairs, lounge chairs, mattresses or pillows is not permitted in the reflection pools.
- -No fireworks or drones are allowed on the facilities.
- -Comply with all rules published in the building and in the pool area.
- -Park your vehicle only in the space assigned to your condo or the area specifically designated for guests.
- -Obey the instructions of the security guards.
- -The pool furniture can only be used where it is located.
- -The use of gas grills or equipment is not permitted in the interior of the apartments, balconies or common areas.
- -Peninsula condominiums are not responsible for the loss of personal items in common areas or any damage to your vehicles in the parking lot.
- -Do not throw anything off the balconies.
- -The Peninsula cleaning, maintenance, administration and security staff do not provide services for private condominiums.
- -For inappropriate behavior that alter the well being of yourself and others or that endanger the physical integrity of the people, Security staff may evict from the Condominium those persons who fail to comply with the Administration Regulation, with no option of subsequent re-entry.
- -The deliberate activation of the fire alarm will cause its immediate eviction of the Condominium, with no option to enter later as visitors.
- -All Adults arriving to the Peninsula must sign this document in front of Security personnel upon check in. There will be no excuse for not knowing these rules as you are signing that you fully understand them. It is your right

to not sign this document and leave the property. Any questions you have about this document need to be asked before you sign.

-Any direct request by companies, property managers or real estate agents without the owner's approval will be ignored.

- -The rules listed here are not at the discretion of the Security or the Administration. The rules are presented and accepted every year in the General Assembly.
- -Decisions taken both by the Administrator and by security personnel shall be based on the Regulation of the Condominium Regime, without exception.

NOTE: If you require a magnetic card to use the beach doors, gyms or access to the condominium, please request it at the Administration Office at the mezzanine

level. You must make a refundable deposit of \$ 500.00 pesos per card. Each lost card will cost \$ 500.00 pesos that will be deducted from your deposit.

We wish you and your family a wonderful stay at Peninsula Vallarta Residential. All adult guests have read the above rules and agree to abide by them.
